Codes of conduct when travelling by school bus

To facilitate student transportation to school, a school bus service has been arranged. Please adhere to the following safety measures. When the bus is in motion,

- Students are not allowed to leave their seats.
 - Students are not allowed to talk to the bus driver.
 - Students are not allowed to shout, eat, or drink on the bus.
 - Do not stick out your head, put your hands or any parts of your body out of the windows.
 - Do not play with the emergency exit.
1. Students are required to follow the instructions given by the school bus driver when boarding and leaving the school bus.
 2. Parents should co-operate with the bus driver. Do not bring bulky things onto the school bus.
 3. Please be punctual. Please arrive at the pick-up point 5 minutes earlier. The bus driver will not wait for latecomers.
 4. Parents are required to **pick up your child on time**.
 5. Please inform the school bus company or the school if the student cannot attend school on that day.
 6. The school bus company will only pick up and drop off the students at the designated place.
 7. If no one picks up the student, the school bus company will send the student back to school (before 6:00p.m.) or to the police station (after 6:00p.m.) for safety purposes.
 8. Please inform the teachers in the handbook or with a letter if a student does not take the school bus after school. Please do not inform the school by phone. **Verbal information is not accepted**. Parents should also contact the school bus company directly.
 9. Any changes of the after-school arrangements should be applied in **writing in advance**.
 10. Class teacher will collect the school bus fee every month, from September to July. Fees are payable for 10½ months each year, regardless of school holidays. **Parents are advised to settle the bus fee on the first week of each month**.
 11. The school bus is under CCTV surveillance. The data or videos captured by the CCTV system may be used for safety and monitoring purposes.
 12. Parents agreed to **give consent for the bus company of your child to be video/photo recorded for safety purposes**.
 13. Please be informed that your child is advised to take the same school bus before or after school arrangement.
 14. If you have any inquiries, please contact the school bus company directly. If your child violates the safety measures of the school bus company, the school has the right to cancel the subsidy or the school bus company has the right to stop providing the services.
